Meeting was called to order at 1:28 p.m. by President: Nancy Casteel.

Susan Goodman talked about the CEU requirements changing. They are finalized by the Advisory Committee but we are waiting for legislative approval. This change will help pick-up hours more easily. Changes will include 10 CEU hours to 15 CEU hours every three years. We have one of the lowest CEU requirements nationwide. CPR changed to 2 hours every three years. Fifteen hours or less of independent or self-study, written and oral, will be reviewed by the Advisory Committee by a written report. Remember, this is not official until it is approved by the legislature, which starts February 2005. This will affect this CEU's period. There will be a limit on laser CEU's of two hours.
