1:35 p.m. Mr. Matt Dohlman, introduced himself and his background. He graduated from O.U. as a Physician Assistant and has been practicing since 2004. He also worked four years as a medical technologist in chemistry. Mr. Dohlman's two hour power point presentation included but was not limited to the following:

- Actinic keratosis: precancerous
- Actinic chelitis: lower lip sun damage
- Bowens disease: squamos cell carcinoma in situ; confused with eczema and psoriasis
- Seborrheic keratosis
- Squamos cell carcinoma: 2nd most common cancer
- Basal cell carcinoma: #1 most common cancer; includes superficial basal cell carcinoma, morpheaform basal cell carcinoma, nodular basal cell carcinoma, and pigmented basal cell carcinoma
- Atypical Nevi: 6mm or larger
- Tool: dermoscopy to view nevi under: uses oil and increases viewing areas 10X plus
- Atypical nevi vs- melanoma: irregular globules, regression structures, and network pattern
- Melanoma mimics: recurrent nevi, seborrheic keratosis, dermatofibroma, blue nevus
- Medium depth peel is 45% TCA: few weeks downtown
- Best sun screen: Blue Lizard from Australia. To order: Bluelizard.net
- Skin and cancer brochures
